Dear Parents,

Congratulations, you are the proud parent of a P.S. 329 *Surfside Senior!*

In celebration of this significant milestone, we have planned a number of fun filled senior activities. In order for your child to be eligible to participate in these specially planned events, your child is expected to demonstrate the following:

E~ Strive for *Excellence*

M~ *Make* good choices (socially and behaviorally)

P~ Come *Prepared* for their day (ready to learn; submit homework, regular attendance/punctuality)

O~ Have *Outstanding behavior*

W~ *Work hard* in every way (in class and in their school community)

E~ *Encourage* others to do well

R~ Have *Respect* for themselves and others

Each day your child will earn "**Senior Points**" for exhibiting the above expectations. By acquiring the maximum number of points (550-600), your child will be eligible to attend all senior activities. Please note, if your child does not earn the maximum points then he/she may not be eligible to attend all senior activities.

**For your convenience, the cost of the Senior Dues can be covered by participating in the Hershey Candy Fundraiser:**



Each box of candy holds 30 bars which sell for \$2.00 each

- For each box sold, \$27 will be applied to your child's Senior Dues expense (the balance covers the cost of the candy which goes to the Hershey Candy Company).
- Candy boxes will be distributed one at a time. As your child sells each box they must submit the total value of the box (\$60) prior to receiving a second box.
- If your child sells 8 boxes of Hershey Candy, \$216 (8 boxes x \$27) will be credited to your child's Senior Dues, leaving a balance of \$19 to be paid in cash or by money order.
- You may opt to sell as many/few boxes as you choose (any/all of the dues may be paid in cash or by money order).
- Please do not allow your child to sell candy door-to-door without adult supervision.
- The balance of Senior Dues must be paid by **June 1<sup>st</sup>**
- In order for your child to participate in Senior Activities he/she must have an adequate number of Senior Points (Dec-May). Your child currently has \_\_\_\_\_ **Points**

If you would like your child to participate in the Hershey Candy Fundraiser, please complete the attached consent form and return to your child's teacher. Please note, in the event your child does not participate in senior activities, no money may be refunded from candy sales.
